

PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980

NORFOLK COUNTY COUNCIL

(METHWOLD FOOTPATH NO. 4)

DIVERSION ORDER 2021

This order is made by Norfolk County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

Methwold Parish Council and Kings Lynn and West Norfolk Borough Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situate at Methwold and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up from the date of confirmation of this order.
2. There shall from the date of confirmation of this order be a public footpath over the land situate at Methwold and described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this order.
3. Where immediately before the date on which the highway is diverted in pursuance of this Order there is apparatus on, under or over that highway belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

Footpath No. 4 (Part) The full width of the path starting at grid reference TL 7326 9483 (point A on the map contained in this order) and running in a generally south easterly direction for approximately 38 metres to meet the U21375 Globe Street at grid reference TL 7329 9482 (point B on the map contained in this order).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

Footpath No. 4 (Part) Starts at grid reference TL 7326 9483 (point A on the map contained in this order) and runs in a generally east north-easterly direction for approximately 10 metres and then a south easterly direction for approximately 26 metres to grid reference TL 7329 9482 (point C on the map contained in this order). The width of the path is 2 metres.
